LOOKING AHEAD

The Pirates' Alley Art Show and Festival is coming up fast:

Thursday, March 26th- Meet and Greet at Spring Fiesta House, 6:30 or 7:00 pm until----

Friday, March 27th- Quick Draw Competition, 10:00 am-12:00pm. Juror-Phil Sandusky. Paintings displayed and available for sale in Pere Antoine Alley from 1:00 – 4:30 pm.

Saturday, March 28th and Sunday, March 29th- Pirates' Alley Art Show, Set up from 8:00-10:00 am. Show from 10:00 am – 6:00 pm. Brass band leads second line parade at 11:00 am. Awards given around noon. Juror-Martha Guthrie.

What to do next:

- Send in your application form and check as soon as possible. **The application deadline has been extended to March 23rd.**
- Look for the acceptance letter in your email inbox. This will be sent to all members, even if you have not yet sent in your application form.
- Go to City Hall for your Special Events Occupational License. Make sure you take:
 - copy of acceptance letter
 - Valid Louisiana ID
 - Previous year's Special Event License if you have oneThe license should not cost you anything if you are on the list of NOAA members.

Preparing for the Show:

You will need the following items:

- Hardware Cloth, approximately 6 x 6 feet (one roll). This can be found at Home Depot or Lowe's.
- Black zip ties to secure the hardware cloth to the fence.
- Your artwork. Be sure it is framed (or gallery wrapped) and wired for hanging.
- Curtain hooks or S-hooks for hanging the artwork on the hardware cloth.
- Clear plastic to cover your art in case of rain or bad weather. Clear shower curtains work well.
- Warm clothing, a hat, a chair or two, water and/or beverages of your choice, snacks.
- Cart or helpful people to transport your stuff to the alley.
- A chip reader! (Please read the following page...)

This year we are allowing a print rack and prints, as long as they are signed, numbered, and clearly marked as prints. Only original work is allowed to hang on the fence.

We ask that if you sign up for the Pirate's Alley Show, you commit to attending both days, even if there is a potential for inclement weather.

Lessons Learned the Hard Way:

So, funny story... Oh, wait. It wasn't funny at all.

You may have heard about all businesses being required by law to switch over to a chip reader to enhance security for credit cards.

Perhaps you thought, as I did, that it didn't really matter, since you could still swipe the cards with your card reader and you don't use it very often anyway.

Unfortunately, this is not the case. Almost two months! after a sales transaction was completed at an art show, I received this email from my square account. I was given no chance to respond to the dispute or contact the buyer in any way.

A cardholder has disputed a payment you processed on December 07, 2019. They've filed a claim with their bank and their bank has notified us that this is an EMV payment dispute, which means this payment was processed in a way that isn't compliant with credit card companies' security guidelines (swiping a chip card when it should have been dipped into a chip reader).

Dispute Reason: **EMV liability shift**

You: Your linked bank account will be immediately debited for the amount of \$65.00 if these funds are not available in your Square balance.

Square: The banks don't give us any rights to challenge this claim because it didn't comply with their guidelines. Unfortunately, federal privacy regulations also prevent us from giving you the cardholder's contact info. Check out our page on the [EMV Liability Shift](#).

The Bank: To minimize fraud, bank regulations transfer liability to merchants that swipe chip cards when they should have been inserted into a chip reader. These regulations apply to all card processors.

The Lessons:

- **Purchase a chip reader before your next art show.**
- **Never swipe a card with a chip, they must be dipped in the chip reader.**
- **Even if a buyer seems genuinely nice, he could be a scam artist (or very forgetful about his purchases?)**

I still have no idea why this transaction was disputed by the buyer, but he now has a free framed print, and I am thankful that it was not a more expensive original. Hopefully after reading this, you won't have to learn this the hard way too.
